# a) Bayberry

Driveways and sidewalks replacements: Targeting 1-3 at a time; 4 driveways are complete and sections of sidewalks are complete.

A new retaining wall has been constructed to control erosion/shifting and to define backyard area for residents.

Gutter Guards: Have been installed on units that back up to the tree line.

Garage Doors: All the garage doors are being repainted.

Club House: Possibility of constructing a clubhouse is being discussed.

Garage Sale: Set for June 2nd, Rain date June 9. Encouraging other neighborhoods to participate.

Walk-through Inspection: Scheduled for April 21, Rain date April 28.

# b) Moss Creek

Driveway Replacement: Project underway; All driveways to be replaced on a priority basis, with 7-8 driveways being replaced per year.

Annual Walk-through Inspection: Scheduled for April 12.

Landscaping: Master plan underway. Nature's Way Landscapers are now being used. Reserve fund will cover this.

Sinking Mailboxes: Repair in process.

# c) Moss Creek Village

Driveways: Concrete driveways being replaced, 3 driveways replaced per year.

Landscaping: Replacement for residents provided on request. Some residents request self-maintenance.

Tree Removal: Ash trees along north neighborhood property line have been assessed, dead and at-risk trees identified with green and white tags, respectively. Gathering quotes for removal. Some trees are on Winslow Farm property and one is on a WF resident's property. *Discussed plan to coordinate efforts with costs to be covered by appropriate party.* 

- IV. Street Signs: Wooden street sign replacement quotes and style options are being reviewed
- V. **Neighborhood Social Gathering**: The Board is discussing having a neighborhood gathering possibly by the gazebo in Sweetbriar.
- VI. Maintenance of Common Areas:
- a) **Walkways**: Replacement complete, will be stained when the weather allows.
- b) **Sweetbriar Concrete Replacement**: Plan to replace common area concrete/brick. A Bayberry owner tripped over an uneven sidewalk in Sweetbriar and broke her wrist. This sidewalk is the adjoining property owner's responsibility to maintain.
- c) Pond Maintenance: Davey Group is still working on the overall plan for the entire pond system.
- d) **Other common area concerns**: Discussed concerns about straw, tree branches is been dumped in common areas
